This has reference to your application Id No. 3295-26/11/2018 seeking accreditation by National Board of Accreditation to the UG Pharmacy program offered by **Nehru College of Pharmacy, Nila Gardens, Pampady PO, Thiruvilwamala, Trichur District, Kerala- 680588.**

2. An Expert Team conducted on-site evaluation of the program from **22nd to 23rd June, 2019.** The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The competent authority in NBA has approved the following accreditation status to the program as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The program has been granted accreditation for three years. **Nehru College of Pharmacy, Nila Gardens, Pampady PO, Thiruvilwamala, Trichur District, Kerala- 680588** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible to be considered by the concerned Committee in NBA for further processing of the accreditation status. This could entail further extension of accreditation or a visit, as deemed appropriate by NBA Committees.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Nehru College of Pharmacy, Nila Gardens, Pampady PO, Thiruvilwamala, Trichur District, Kerala- 680588** as a whole. As such the Institute should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
6. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the Table in paragraph 2, appears on the website and information bulletin of your Institution.
